Competition Awards

The Awards Ceremony will begin at 6:30 PM. Each competition will have a 1st, 2nd and 3rd place winner. Each person (or team member) that places will receive either a medallion or a trophy, depending on the competition. However, in addition to a medallion or trophy the First Place Winner(s) of each competition will receive the following:

- **Free entry fees in the 2013 ACSP professional competition of their choice**
- **Free one year membership in ACSP**

Additional awards will be given out to the competitor with the highest combined overall scores: 1) Female Hair Shaping **and** Female Daytime Finish and 2) Male Hair Shaping **and** Daytime Finish. School of the Year will be awarded to the school with the highest accumulated points for the top three places in each competition.
